About England Athletics

England Athletics Ltd, a company registered in England under number 5583713, and our registered address is at Athletics House, Alexander Stadium, Walsall Road, Perry Barr, Birmingham, B42 2BE, UK (we, us, our).

We are the membership and development body for grass roots athletics and running clubs in England. We support our member clubs and athletes from start to finish with, for example, coach development opportunities, competitions and events, resource provision for whole club development planning, volunteer training and recognition, welfare support and event registration.

What these Terms do

These terms (Terms) apply to the use of our website at www.englandathletics.org (the website). These terms also apply to any services accessible through the Website, unless separate or additional terms apply, in which case they will be displayed on-screen or be made accessible via a link.
